**Please read the following to learn more about our privacy policy.**

GMD Promotions and its related companies ("Gymnastic Merchandise Direct") have a firm Commitment to privacy in accordance with the Privacy Amendment (Private Sector) Act 2000, which takes effect in December 2001. This privacy policy covers all personal information that we hold.

### **YOUR PERSONAL INFORMATION IS IMPORTANT TO US**

GMD Promotions recognises that your privacy is very important to you and that you have a right to control your personal information. We know that providing personal information is an act of trust and we take that seriously. We will take reasonable steps to ensure that the information that we collect, use and disclose is accurate, complete and up to date.

### **COLLECTION OF INFORMATION**

Whenever we collect personal information from you we will do so in a lawful and fair way. We will also advise you how and where to contact us. Only information you provide GMD Promotions with directly will be collected, such as through subscribing to various products & services, or identifying yourself when requesting information to be sent to you. The only personal information we collect is what you tell us about yourself. For example, when you fill out a request form, we collect the details you enter to enable us to post information to you. When you answer questions about what you would like to see we keep this information so as to better serve you.

### **INFORMATION & PROMOTIONAL EMAILS**

From time to time we will send you relevant information emails regarding products and services which you have previously registered your interest in. If you are receiving promotional information from GMD Promotions and do not wish to receive this information any longer, you may send an email advising "Opt out" and your information will be deleted from our system.

### **DISCLOSING & INFORMATION SHARING**

GMD promotions will not sell or rent your personally identifiable information to anyone.

### **SECURITY**

We are committed to protecting your privacy and will take reasonable steps to ensure that the information we collect is protected from loss and misuse and from unauthorised access, modification and disclosure.

### **ACCESS TO THE INFORMATION WE HOLD & OPT OUT**

You can access your personal information upon request. However, there are occasions when this access may be denied under the exemptions contained in the Act. We will provide you with a link- contacting us if you wish to opt out from receiving further marketing offers. In accordance with the Act, direct marketing offers will contain an opportunity to opt out.
